- 2. Approval of Minutes from the Prior Meeting: J. Loker made a motion to amend the minutes of the January 22, 2024, meeting to correct the word "Beauty" to read "Beautify". J. Fraga Muller passed her gavel to J. Mahon and then seconded the motion. The motion passed 3-0. J. Loker then motioned to accept the amended minutes of January 22, 2024; J. Fraga Muller seconded the motion. The motion passed, 3-0. J. Mahon returned the Chair's gavel to J. Fraga Muller.
