<p><u>Veterans' Tax Credits</u></p> <p>V-1 Veteran/Spouse V-2 2 Veterans</p> <p>Qualifications</p> <p><u>RSA 72:27 - RSA 72:34</u></p> <p><u>Deadline to File:</u> April 15, 2018</p> <p><u>Applications:</u> Must be completed in the Assessor's Office.</p> <p><u>Please Submit:</u> Applications by April 15th, each year.</p> <p>Applicant <u>must</u> re- qualify at-least once every 5 years.</p> <p>Applicant <u>must</u> supply copy of current NH driver license.</p> <p>If property in a Trust, applicant <u>must</u> supply copy of that Trust (ALL Pages).</p>	<p><u>Current Credit Amount:</u> \$500 Upon adoption by a city or town pursuant to RSA 72:27-a, shall be an amount from \$51 to \$500.</p> <p><u>Applicant/Veteran:</u> <u>Must be a resident of New Hampshire for at least one year as of April 1st. Must provide proof of service and residence and supply a copy of Form DD-214.</u></p> <p><u>The Veteran Tax Credit:</u> Shall be subtracted each year from the property tax on the Veterans' residential property. However, the surviving spouse of a resident who suffered a service-connected death may have the amount subtracted from the property tax on any real property in the same municipality where the surviving spouse is a resident.</p> <p><u>The following persons shall qualify for the Veteran Tax Credit:</u></p> <ul style="list-style-type: none">a) Every resident of this state who <u>served not less than 90 days</u> in the armed forces of the United States in any qualifying war or armed conflict listed in this section and <u>was honorably discharged</u> or an officer honorably separated from service; or the spouse or surviving spouse of such resident, provided that Title 10 training for active duty by a member of a National Guard or Reserve shall be included as service under this subparagraph;b) Every resident of this state who was terminated from the armed forces because of service-connected disability; or the surviving spouse of such resident; andc) The surviving spouse of any resident who suffered a service-connected death. <p><u>Service in a qualifying war or armed conflict shall be as follows:</u></p> <ul style="list-style-type: none">a) <u>"World War I"</u>: Between April 6, 1917 and November 11, 1918, extended to April 1, 1920 for service in Russia; provided that military or naval service on or after November 12, 1918 and before July 2, 1921, where there has prior service between April 6, 1917 and November 11, 1918 shall be considered as World War I service;b) <u>"World War II"</u>: Between December 7, 1941 and December 31, 1946; Note: This time period also includes a Merchant Marine <u>who was activated</u> during WWII between 12/7/1941 and 8/15/1945;c) <u>"Korean Conflict"</u>: Between June 25, 1950 and January 31, 1955;d) <u>"Vietnam Conflict"</u>: Between July 1, 1958 and December 22, 1961, if the resident earned the Vietnam Service Medal <u>or</u> the Armed Forces Expeditionary Medal;e) <u>"Vietnam Conflict"</u>: Between December 22, 1961 and May 7, 1975;f) <u>"Persian Gulf War"</u>: Between August 2, 1990 and the date thereafter prescribed by Presidential proclamation or by law; andg) Any other war or armed conflict that has occurred since May 8, 1975, and in which the resident earned an Armed Forces Expeditionary Medal <u>or</u> Theater of Operations Medal.
